Re: F.E.R.C. Tariff No. 100.70.0 cancels F.E.R.C. Tariff No. 100.69.0 (Docket No. IS17-581-000).

Dear Secretary Bose:

The accompanying tariff is sent to you for filing in compliance with requirements of the Interstate Commerce Act (ICA) and the Commission regulations. This tariff is issued by Explorer Pipeline Company ("Explorer") and bears the designation as FERC No. 100.70.0. The tariff is filed to become effective on January 1, 2018.

FERC Tariff No. 100.70.0 contains the following revisions:

- Item No. 5 Definitions references the current Shipper's Manual dated January 1, 2018 and incorporates the manual by reference and is attached herein;
- Item No. 10, Commodity & Specifications, Section a has been added to comply with the requirement of § 341.4(c);
- Item No. 20, Minimum Delivery at Destination has been revised to clarify that less than 5,000 barrels may be delivered at destinations if operational issues warrant it;
- Item No. 90, Proration of Pipeline Capacity, has been updated to reflect the January 1, 2018 Petroleum Products Proration Policy which was revised to clarify that allocations to Regular and New Shippers on the smaller line segments would be rounded to 5,000 barrel increments; and
- Tables of Rates Part II, Part III, Part IIIA, Part IV, and Part IVA have been revised to reflect a general rate increase averaging 2.25% across all destinations.
- Tables of Rates Part III and Part IV have been revised to cancel the Galena Park Origin due to the fact that it is currently out of service.

Explorer's tariff filing is based on its market-based authority granted by the Commission in Docket OR99-1-000, issued June 30, 1999 (87 FERC ¶ 61,374). For the ease to our Shippers, Explorer has maintained one tariff structure, which includes both intrastate (non-jurisdictional) and interstate rates (FERC jurisdictional).


