Dear Secretary Bose:

[N] This transmittal letter is sent to correct Transmittal Letter 360 which was incorrectly numbered and filed with FERC No. 100.77.0 by Explorer Pipeline in Docket No. IS19-76-000. All other information in the tariff and transmittal letter is unchanged.

The accompanying tariff is sent to you for filing in compliance with requirements of the Interstate Commerce Act (ICA) and the Commission regulations. This tariff is issued by Explorer Pipeline Company ("Explorer") and bears the designation as FERC No. 100.77.0. The tariff is filed to become effective on January 1, 2019.

FERC Tariff No. 100.77.0 contains the following revisions:

- Item No. 90, Proration of Pipeline Capacity, updated to reflect the location of Explorer's Proration Policy on the Carrier's website at www.expl.com.
- Tables of Rates Part II, Part III, Part IIIA, Part IV, and Part IVA have been revised to reflect a general rate increase averaging 1.75% across all destinations.


